RULES AND GUIDELINES

1. All regular members of PAMET-USA, Inc. in good standing as defined by the local chapter are qualified to run for office in any position. Their chapter must be current in their membership dues up to 2020.
2. Nominees must be an active member of their local chapter for at least 2 years and served as an officer.
3. Nominees must be fully registered delegates at the virtual convention & must be present at the virtual convention.
4. Nominees must be licensed and /or certified Medical laboratory professionals.
5. Nominees must be willing to devote time & commitment to serve and attend the BNC & EBM during their term of office.
6. ADDENDUM for President-Elect and Vice-Presidents Only: Must have attended 2 consecutive BNCs and 2 consecutive EBMs.
7. The official Nomination Form must be used and generated from our website.
8. A completed nomination form and 1 minute video campaign speech should be emailed to the designated chairman of Nominations & Elections with both signatures of nominee & nominator to Nileba117@att.net
9. Because we will be accepting nominations solely through email, it is understood that the electronic signatures on the nomination forms are binding and are reflective of the nominee's acceptance of the nomination.
10. Upon receipt of the nomination form, the chairman of Nominations & Election shall reply by emailing back to the nominator. This complete process shall constitute the official nomination process.
11. The opening dates of the nominations will be on July 25 to August 25,2020 and is extended until September 20, 2020. Nominations that are emailed thereafter shall be null and void.
12. The completed roster of candidates shall be posted through the President's communique and on our website.
13. In the event that there are opened positions after the deadline, there will be an open nomination on Monday Sept. 21 until midnight.
14. Regulations not covered above shall be covered by the bylaws of the constitution and the Admin Manual.
